Consider and possibly authorize the County Judge to execute an Amendment to Hangar Lease Agreement between Huslin One Aviation and Jefferson County, to add a storage room to Hangar leased at the Jack Brooks Regional Airport.

AMENDMENT TO HANGAR LEASE AGREEMENT

THIS AMENDMENT TO LAND LEASE (the "First Amendment"), is made and entered into effective this **31st day of March, 2016**, by and between Jefferson County, ("the lessor") and the **Huslin One Aviation, LLC**. ("the lessee").

Whereas on March 23, 2015, Huslin One Aviation, LLC leased 6,750 square feet from Jefferson County for 5 years as shown in the attached lease;

Whereas the parties desire to amend the lease to change the area leased by lessee, from the Lessor, thereby redefining the term, "Premises" and adjusting the rent for the Premises (as redefined).

NOW, THEREFORE, IT IS HEREBY AGREED AS FOLLOWS:

Section 2 to the lease is hereby amended to read as follows:

Rate. For and in consideration of the rent and covenants herein contained, Lessor agrees to lease space as follows: "**Hangar 7 – Unit 2**" containing **6,750** square feet, more or less, of hangar space at a rate of **\$2.52** annually per sqft (**\$1,417.50/month**), and "**Hangar 7 – Office F**" containing **276** square feet, more or less, of storage space at a rate of **\$4.35** annually per sqft (**\$100.00/month**), for a total (**\$1,517.50/month**).

Section 5 to the lease is hereby amended to read as follows:

Due Date. All rent shall be payable monthly, in advance, and shall be due on the first day of the month and shall be considered past due on the tenth day of each month. Rental installments not paid before the tenth of the month following its due date shall be assessed a \$50.00 late fee. In consideration for paying the annual rent in advance prior to taking possession of lease space, the Lessor agrees to discount the annual rate by two (2) months of monthly rent, for a total annual rental rate of **\$15,175.00**.

Except as otherwise amended by this Amendment, the all other provisions of the original lease shall remain in full force and effect.

Lessor has executed and delivered this Amendment as of the date first mentioned above. Lessee hereby executes the foregoing amendment for the purpose of binding itself to the terms of this Amendment and to the herein referenced lease.



1. Uretek ICR will provide all labor, materials and supervision to fill subterranean-voids using the Uretek Method™ to raise and/or stabilize the slab foundation at injection locations on the Project.
2. Injections will be made by drilling holes. The holes resulting from the drilling will be sealed with either wood putty or grout (as applicable) upon completion of the work.
3. Owner hereby accepts all responsibility for and agrees that Uretek ICR is not responsible for any damage to or resulting from damage to, (1) plumbing, (2) sheetrock, (3) wall covering, (4) carpet, (5) flooring, (6) door and/or window frames, (7) any other rigid material(s) and/or (8) any other damage resulting from Uretek ICR's work.
4. Any re-mobilization required because of lack of preparation by the customer will result in a \$1,000.00 remobilization charge.
5. Uretek ICR will Lift and stabilize sidewalk at Walter Umphrey State Park; approximately 735 sq ft for the sum of Eight Thousand Eighty Five dollars (\$8,085.00), plus all applicable taxes (the "Service Fee"). Uretek ICR intends to use 735 pounds of material. Work beginning after 5pm on Friday thru 5am Monday will cost an additional \$1,000.00. Changes to the work will not be undertaken without a written change order signed on behalf of Uretek ICR and by Owner. Upon the parties' signing of a written change order, Uretek ICR will supply and inject additional material at a cost of \$10.00 per pound. Payment in full of the Service Fee is due upon Uretek ICR's representation that the work is complete regardless of whether Owner requests additional work by executing a change order as provided below. All invoices which are not paid upon completion of the work shall bear interest on the amounts then due at the rate of twelve percent (12%) per year with interest to accrue five (5) days from the date of Uretek ICR's invoice.

The Service Fee is based on Uretek ICR's investigation of the conditions and factors affecting the work to be performed, including, without limitation, soil conditions, void spaces, moisture levels, thickness of concrete and Owner's input to Uretek ICR regarding those and other pertinent conditions.

Gentlemen:

In compliance with Section 114.023 of the Local Government Code, I herewith present the monthly report of the financial condition of Jefferson County as of December 31, 2015 together with the results of operations of the budget for the third period then ended.

Revenue:

Total budgeted revenue collected for the three months ending December 31, 2015 is \$18,178,345. Budgeted Revenues are \$118,954,643 leaving \$100,776,298 in revenue to be collected in order to meet our budgetary revenue goals. Highlights of revenues are as follows:

Property Taxes:

Property tax collections are \$13,571,477 for the first three months of the year. This amount represents 17% of the budgeted amount of \$80,959,960.

Sales Taxes:

Eight percent of budgeted revenue for sales taxes has been collected. Sales Tax revenue is budgeted to be \$23,925,000.

Page Two

Licenses & Permits:

Seventeen percent of budgeted revenue from Licenses & Permits has been collected. Licenses & Permits are budgeted to be \$414,620 for the year.

Intergovernmental:

Seventeen percent of Intergovernmental Revenue has been collected. Intergovernmental Revenue is budgeted to be \$1,454,559.

Fees:

Eighteen percent of the budgeted revenue for Fees has been collected. Revenue from Fees is budgeted to be \$10,382,154 for the year.

Fines and Forfeitures:

Twenty-two percent of Fines and Forfeitures have been collected. Revenues from Fines and Forfeitures are budgeted to be \$1,575,000.

Interest:

Seven percent of the budgeted revenue for Interest has been collected. Revenues from Interest are budgeted to be \$219,350.

Other Revenues:

Nothing has been collected in Other Revenues. Revenues from Other Revenues are budgeted to be \$24,000 for the year.

Expenditures:


Overall for the County's budgeted funds, twenty-four percent of the expenditures have been spent.
