5 compliment all the ladies. You-all doing great. Good
6 work.

7 THE COURT: Well, the only comment I have, I
8 have been telling Ms. Garcia on a regular basis, every
9 one of those cases is handled by either myself or Judge
10 Davis; but they're all filed in judge -- they're all
11 given credit to Judge Gerson; but --

12 BECKY GARCIA: We're fixing to go live in
13 two weeks.

14 JUDGE FLORES: Ma'am?

15 BECKY GARCIA: In two weeks we're going to
16 go live with our new program. You'll get credit --

17 TOM MANES: We need to change the computer
18 because other judges -- why is that --

19 BECKY GARCIA: Because it's civil.

20 THE COURT: Because it's civil in nature.

21 BECKY GARCIA: It's filed as a civil nature.

22 THE COURT: We have civil jurisdiction; but
23 for the last --

24 TOM MANESS: Yeah.

25 BECKY GARCIA: It is.

1 JUDGE FLORES: That's thousands of cases
2 that Judge Gerson got credit for that Davis and I have
3 done.

4 TOM MANESS: Well, I bet he wasn't griping.

5 BECKY GARCIA: For two years, Rick and I
6 have been working with our MIS department to rewrite a
7 program that will now we can determine if it came from
8 Court 2 or Court 3; so -- next month, in January they
9 should be getting credit for some.

10 THE COURT: That just gives us more cases.

11 TOM MANESS: That's right. You're already
12 about the top in the state with your load; I don't know
13 why you'd want more.

14 THE COURT: Number 7 in the state out of
15 254.

16 TOM MANESS: Yes.

17 THE COURT: Mrs. Presley, any new
18 applications for consideration?

19 CATHERINE PRESLEY: No, sir.

20 THE COURT: Okay, Mrs. Godina, any
21 complaints?

22 MARY GODINA: No, sir.

23 THE COURT: Report from the treasurer's
24 office, Mr. Funchess?

25 TIM FUNCHESS: The treasurer's report is in

1 front of you-all, if you have any questions. Sent
2 letters out 1st of November for those folks who have
3 pledged collateral in the form of real property. I've
4 gotten tax statements from all but three of those. So,
5 I'm going to get with Mr. Day and see if he can send an
6 e-mail out to these other three people.

7 THE COURT: Okay. Report from the auditor's
8 office?

9 RHONDA BRODE: I've handed out the report to
10 everyone. There's nothing extra in there.

11 THE COURT: Okay. All right. Is there any
12 new business to be considered?

13 (No response.)

14 THE COURT: Okay. Well, if there's nothing
15 further then, Judge Lively?

16 JUDGE LIVELY: Motion to adjourn.

17 BECKY GARCIA: Second.

18 Tom MANESS: Second, third, fourth, and
19 fifth.
