20 is in order I'll sign the papers. Any other
21 applications, that's the only one?

22 CATHERINE PRESLEY: That's it, sir.

4 judges and anyone else that wants to, to look at it;
5 basically what I'm looking for is someone who's
6 knowledgeable of the attorneys, to let me know who's --
7 who's deceased, if they know of anyone who is no longer
8 practicing, just kind of make notes for me and that
9 might help us in the clean-up.

10 JUDGE FLORES: The ones to help out on that
11 would probably be Tina and Mary and probably Mrs.
12 Garcia?

13 BECKY GARCIA: We looked at it.

14 MARY GODINA: We tried.

15 JUDGE FLORES: Oh, okay.

16 RHONDA BRODE: They asked me to have the
17 judges --

18 JUDGE FLORES: You-all couldn't figure out
19 who's still practicing?

20 BECKY GARCIA: Who's dead.

21 MARY GODINA: Who's deceased.

22 BECKY GARCIA: I mean, there's names on
23 there we don't recognize; like before us.

25 we came.
