

1 out.

2 JUDGE FLORES: Okay. Any comments,
3 Mr. Knauth?

4 PAT KNAUTH: None for me.

5 JUDGE FLORES: The third item on the agenda
6 is the consideration and approval for applications.
7 Ms. Presley, go ahead.

8 CATHERINE PRESLEY: Yes, sir. I have one.
9 It would have been renewal but she expired on 2/16.
10 It's an agent license. It's for Tiffany Graham Cousins.
11 She works for Keith Day. So it's a new application.

12 JUDGE FLORES: Okay.

13 CATHERINE PRESLEY: Everything is in order.

14 JUDGE FLORES: Are there any questions or
15 discussions on this application?

16 (None.)

17 CATHERINE PRESLEY: And that's Professional
18 Bail Bonds.

19 JUDGE FLORES: Okay, if there's none, when
20 the application is presented to me, I will sign it.

21 KEITH DAY: Judge?

22 JUDGE FLORES: Yes.

23 KEITH DAY: One thing we had talked about in
24 the past is about the criminal background checks that we
25 would do for ourselves now, Cathy.

1 CATHERINE PRESLEY: Uh-huh, yes.

2 KEITH DAY: And we talked about the length
3 of time it takes to get those things back. She got --
4 we got that one back, I think, within like a week and a
5 half or two weeks.

6 JUDGE FLORES: Well, that's good.

7 KEITH DAY: So, it didn't take very long at
8 all to get it.

9 JUDGE FLORES: So the procedure is working?

10 CATHERINE PRESLEY: Yes, sir.

11 JUDGE FLORES: Good. Okay.

12 Mrs. Godina, any complaints against bonds
13 men?

14 MARY GODINA: No, sir.

15 JUDGE FLORES: Report from treasurer's
16 office, Mr. Funchess?

17 TIM FUNCHESS: I've distributed my report.
18 I don't think there's any changes from last month.

19 JUDGE FLORES: Any discussion or questions
20 of Mr. Funchess?

21 (None.)

22 JUDGE FLORES: Okay. Report from the
23 auditor's office?

24 RHONDA BRODE: I distributed my report; and
25 I must admit I did not follow-up with Tina, Becky, Mary,

1 anyone last month. Life took over; and just I didn't
2 get to it. So I will follow up about the questions that
3 I had.

4 JUDGE FLORES: Okay.

5 RHONDA BRODE: I did have a question for Tim
6 today on his collateral report; and it's regarding
7 Derrick Dixon and Thomas Snoddy. I just wasn't really
8 sure -- Thomas Snoddy -- Becky, answer me if I'm -- if I
9 say anything out of -- correct me if I say anything
10 incorrect.

11 Thomas Snoddy used to have ASAP Bail Bonds.

12 BECKY GARCIA: Yes.

13 RHONDA BRODE: Now Derrick Dixon does.

14 BECKY GARCIA: Yes.

15 RHONDA BRODE: But we have a CD; and Tim and
16 I looked at them; and there's two different CDs.

17 BECKY GARCIA: We just have to make sure --
18 we can't released the Thomas Snoddy CD until all of
19 those bonds have been written off of it.

20 RHONDA BRODE: Okay.

21 BECKY GARCIA: However, because it's an
22 insurance -- they're writing under an insurance -- and
23 one took over from the other --

24 RHONDA BRODE: Uh-huh.

25 BECKY GARCIA: -- I feel confident that

1 regardless of what bond, it's a Thomas Snoddy bond or a
2 Derrick bond, that insurance company is obligated to pay
3 for it.

4 TIM FUNCHESS: The insurance company does
5 own the CD; but there's two different CD numbers; and
6 the one we have assigned to Thomas Snoddy is different
7 from the one --

8 BECKY GARCIA: Yes.

9 TIM FUNCHESS: There's actually --

10 BECKY GARCIA: Yes.

11 TIM FUNCHESS: There's two CDs.

12 BECKY GARCIA: Right.

13 RHONDA BRODE: And I'm -- I'm not -- you
14 know, I don't claim to be an expert on your end of the
15 world by any means; but I didn't see any bonds or
16 outstanding forfeiture for Thomas Snoddy; and I just
17 didn't want that 50,000 to sit out there if -- if it
18 didn't need to. So -- what do you recommend we do with
19 this -- what's --

20 JUDGE FLORES: Mr. Roebuck, what's the
21 problem with having two different CD numbers? And,
22 Mr. Funchess, also, help us on -- it doesn't make sense
23 to me.

24 TIM FUNCHESS: I mean, when he -- when
25 Thomas Snoddy, you know, put up his 50,000, the

1 insurance company on his behalf put up the CD and had it
2 assigned. They also did the same thing for Derrick
3 Dixon. So, that's two separate people and two separate
4 50,000-dollar CDs.

5 JUDGE FLORES: Collaterals.

6 TIM FUNCHESS: But just one of them --

7 RHONDA BRODE: But one business.

8 TIM FUNCHESS: Well, it's one business
9 but --

10 KEITH DAY: Well, it's under two different
11 licenses, though. I mean those are two separate
12 licenses --

13 CATHERINE PRESLEY: Numbers.

14 KEITH DAY: -- sureties. So, one
15 CD shouldn't have -- I mean, even though they came from
16 the same insurance company, one shouldn't have anything
17 to do with the other.

18 RHONDA BRODE: And we would understand that;
19 but he's no longer active; and he's no longer a licensed
20 bail bondsman in Jefferson County.

21 JUDGE FLORES: Whose that?

22 KEITH DAY: Thomas Snoddy.

23 RHONDA BRODE: Snoddy.

24 KEITH DAY: But does he still have bonds
25 out?

1 RHONDA BRODE: No.

2 TINA BENOIT: Yes.

3 RHONDA BRODE: Does he?

4 CATHERINE PRESLEY: The bonds --

5 TINA BENOIT: He has thirty, forty --

6 RHONDA BRODE: They didn't come out on the
7 report.

8 TINA BENOIT: -- \$40,000 worth of bonds out.

9 CATHERINE PRESLEY: They may not have
10 forfeited; but they're out there.

11 RHONDA BRODE: Okay, I have -- I have no
12 open balance for him. Okay.

13 TINA BENOIT: They're out there.

14 KEITH DAY: How many is there?

15 TINA BENOIT: There's one 15, one 20, one 5,
16 and one \$250.

17 KEITH DAY: So four.

18 THE COURT REPORTER: Say that again, Tina,
19 please.

20 TINA BENOIT: A 15,000; a 20,000; a \$5,000
21 bond out and a \$250 bond out.

22 RHONDA BRODE: Okay. That makes me question
23 what I'm getting from MIS then. That's why the question
24 arose because I didn't see any bonds out there.

25 BECKY GARCIA: What name were you pulling

1 up, Thomas Snoddy?

2 RHONDA BRODE: I just pull up everyone. I
3 get -- I get a major dump of the system for everyone.

4 BECKY GARCIA: Tina, what is that --

5 TINA GILLESPIE: Under Thomas Snoddy.

6 BECKY GARCIA: Okay.

7 CATHERINE PRESLEY: Judge Flores, you could
8 have four agents or more under an insurance company; but
9 they each have their own separate collateral. You have
10 to.

11 JUDGE FLORES: Okay.

12 CATHERINE PRESLEY: Different businesses.

13 RHONDA BRODE: Okay. I feel comfortable
14 with the collateral being out there.

15 JUDGE FLORES: He's got \$50,000 against
16 40,250. Okay.

17 CATHERINE PRESLEY: Exactly.

18 TIM FUNCHESS: As far as collateral, I'm the
19 safe keeper; but when it comes to releasing collateral,
20 I work under the direction of this board.

21 JUDGE FLORES: I understand.

22 Any other discussion on this area,
23 Mr. Roebuck?

24 MR. ROEBUCK: My question was answered. If
25 you've got two different companies and two different

1 CDs, I think that solves that problem.

2 BECKY GARCIA: Well, it's the same
3 company --

4 TOM ROEBUCK: Keith, you're saying it's
5 different licenses?

6 KEITH DAY: Two different licenses. I think
7 we ran into this issue when Derrick got licensed. They
8 wanted to use the same name or something; didn't they?

9 JUDGE FLORES: Yeah.

10 KEITH DAY: The same name of a company; but
11 I -- when we look up information, I don't even think it
12 comes up under the name of the company. It actually
13 comes up -- like when you look me up, it doesn't come up
14 Professional Bail Bonds; does it, Tina? It comes up
15 Keith Day; right? I think it comes up as each
16 individual name that --

17 BECKY GARCIA: Yes.

18 KEITH DAY: The name of the company has no
19 bearing on what -- you know, under the license name.

20 JUDGE FLORES: It's the name of the
21 licensee?

22 KEITH DAY: Under the license name.

23 BECKY GARCIA: It either comes up as the
24 owner of that collateral, or the agent for the insurance
25 company.

1 KEITH DAY: Right.

2 BECKY GARCIA: That's how it's listed.

3 KEITH DAY: But I --

4 RHONDA BRODE: And the report I have doesn't
5 even have the business name. It just says Lexington. I
6 mean it has Thomas Snoddy, and then has Lexington.

7 KEITH DAY: Yeah, because I think they ended
8 up naming -- I think they ended up naming it the same.

9 CATHERINE PRESLEY: Once he expired --

10 KEITH DAY: Once he expired.

11 CATHERINE PRESLEY: -- then they changed the
12 name.

13 JUDGE FLORES: Well, is there any old
14 business we need to go over?

15 (None.)

16 JUDGE FLORES: Any new business?

17 (None.)

18 JUDGE FLORES: Short meeting. Mr. Funchess?

19 TIM FUNCHESS: Motion to adjourn.

20 BECKY GARCIA: Second.

21 JUDGE FLORES: Moved and seconded that we
22 adjourn. All in favor say aye.

23 BECKY GARCIA: Hang on. What about the
24 bonds transaction fee?

25 TINA BENOIT: That's what Roebuck is here

1 for.

2 MARY GODINA: We finally got him here,
3 you-all.

4 TOM ROEBUCK: We made a deal.

5 BECKY GARCIA: Oh, it was that? I thought
6 that was the other part that we were going to talk
7 about.

8 JUDGE FLORES: All right. Mr. Roebuck? Is
9 this something we need to reset or where are we?

10 TOM ROEBUCK: Given the fact I've totally
11 forgotten about what it was, probably be a good idea we
12 reset.

13 MARY GODINA: Are you coming to the next
14 meeting?

15 BECKY GARCIA: I'll discuss it with you
16 after the meeting.

17 JUDGE FLORES: Becky, if you get with him?

18 BECKY GARCIA: Yes.

19 JUDGE FLORES: All right.

20 KEITH DAY: Reset it until July, that way we
21 won't put any pressure on Tom.

22 JUDGE FLORES: It's been moved and seconded
23 that we adjourn. All of those in favor again say aye.

24 (Response.)

25 JUDGE FLORES: All right. Thank you.
