1. Call to Order / Greetings – Chair Theresa Goodness

The meeting was called to order by Chair Theresa Goodness. 2. Consider Minutes of Previous Meeting – Chair Theresa Goodness

3. Treasurer's Report – Treasurer Paul Prosperie

The Treasurer's Report was given by Coordinator Linda McMahan. This was the first report of the 2014 – 2015 Budget Year.

- **Volunteer Hours / Annual Report – Linda reminded members that 2014 volunteer hours were to be turned in by January 15, 2015. These hours will be included in the 2014 Annual Report to be presented to Commissioners Court for their approval and forwarded on to the Texas Historical Commission.**

6. Committee Reports

Archeology – Brenda Jackson shared there will be a special lecture at the McFaddin-Ward House, “Making Heads & Telling Tales,” on Thursday, January 29, 2015. Amanda Danning, a forensic sculptor who specializes in historic facial reconstructions will be in the speaker. The event is free and open to the public. Doors open at 6 PM and the lecture will begin at 6:30 PM.

Ms. Danning has worked in collaboration with countless museums, including several projects with the Smithsonian. Her talk will weave science, art, and extensive research from archeologists and anthropologists as well as her own travels across the American Southwest.
