

TEXAS HISTORICAL COMMISSION HOSTS TRAINING WEBINARS

Texas Historical Commission Offers Free Summer Webinars

AUSTIN, Texas —

Join the Texas Historical Commission (THC) this summer for three, free online workshops. On July 8, the THC's Museum Services Program and Texas Heritage Trails Program are partnering with the Texas Association of Museums to present a webinar on the effective use of images in interpretive storytelling. The THC's Historical Markers Program is hosting webinars on July 22 and August 14 about conducting research and applying for an Official Texas Historical Marker.

“Selecting Strong Imagery for Interpretive Stories” is a one-hour webinar about how to best choose photographs, maps, and other images to incorporate into compelling stories. Instruction will include such examples as exhibit panels, display case text, object labels, signage, outdoor waysides, brochures, and other interpretive printed pieces. It will also touch on the basics of graphic design and composition.

Taking place on Tuesday, July 8, from 10–11 a.m., the webinar is primarily designed for people who work or volunteer for museums, historic sites, tourist destinations, and other organizations that seek to increase traffic to tourism sites in and around their communities. It accompanies a previous series of six workshops about using storytelling in interpretive writing, which were held around the state in June. The instructor for the workshops and webinar is Erin McClelland, an Austin-based independent interpretive specialist who works with small- to medium-sized museums. The historical marker webinars will be conducted by THC staff on Tuesday, July 22, from 2–3:30 p.m. and Thursday, August 14, from 2–3:30 p.m. They are part of an annual series of statewide marker workshops that provide an overview of important historical research fundamentals. Participants walk through a sample Official Texas Historical Marker application and narrative, and are presented information on such topics as historical significance and integrity, primary and secondary sources, research tools, writing the narrative, and the roles of the THC and county historical commissions (CHCs) in the application process. MUSEUM OF THE GULF COAST OPENS TIME CAPSULE

In July, 1994, members of the Museum of the Gulf Coast decided to gather items for a time capsule to be opened in twenty years. This week the public was invited to the opening of a new exhibit at the museum “Fifty Years, Fifty Objects” which features items from Port Arthur’s past. The opening also celebrated the twentieth anniversary of the museum and the fiftieth anniversary of the Port Arthur Historical Society which runs the museum with Lamar Port Arthur.



Unfortunately the time capsule did not weather the years unscathed. Groundwater and possibly chemicals in the groundwater infiltrated the capsule and destroyed most of its contents. Undaunted, museum director, David Beard, promised a new time capsule would be constructed of better materials and water barriers, and would this time be buried above ground water level. The new time capsule will be opened to mark the fifty year anniversary

of the Museum of the Gulf Coast in 2044.

OPEN HOUSES TO HIGHLIGHT MID-CENTURY TEXAS BRIDGES

AUSTIN, Texas —The Texas Historical Commission (THC) is working closely with the Texas Department of Transportation (TxDOT) and the Historic Bridge Foundation (HBF) to engage Texans in conversation about historic bridges. This month and next, the groups will co-host three open houses around the state to discuss bridges constructed between 1945 and 1965, a period marked by innovative designs and experiments with concrete and steel.

Texas retains about 15,000 bridges built during the post-World War II period, and the THC, TxDOT, and HBF are seeking input about which structures best represent that era’s important technological advances. Through extensive surveys, TxDOT identified more than 100 bridges eligible for listing in the National Register of Historic Places (NR). Unlike metal truss structures, most mid-20th century bridges cannot be moved to new locations when roadways require widening or reconfiguration. Through a forthcoming agreement between the THC, TxDOT, and HBF, plans are underway to identify the most significant of the NR-eligible bridges and what steps might be taken to mitigate the loss of others in the future. Public input is a critical part of the project. The three open houses will offer the public an opportunity to view photos of the historic bridges, ask questions of those involved in the process, and provide input about significance and future steps. Additional information is available on both the THC and TxDOT websites. The events will take place on Tuesday, July 29, at the Emmie Seele Faust Memorial Library in New Braunfels; Tuesday, August 5, at the Grapevine Visitor Information Center in Grapevine; and Thursday, August 14, at the Moody Mansion in Galveston. Beaumont Heritage Society - Projects Langham House

In 1898, the Langham family built their home at 1561 Park Street. Their daughter, Ellen, married William French (son of David French, son of John Jay French) and they lived there for a time. The house has been designated a Historical Cultural Landmark and is eligible to be on the National Register of Historic Places.

The house was facing demolition, but was donated by the owner, Ms. Brenda Wilridge, to the Beaumont Heritage Society. The Heritage Society partnered with Beaumont Main Street's Save and Secure program to move it temporarily to the corner of Royal and Park. It has been purchased and will be permanently placed just one block away and restored.


