Legal Notice Invitation for Bids

Dear Bidders:

You are invited to submit Bids in accordance with specifications packet, Invitation for Bid IFB Masonry Restoration at the Ben J. Rogers Regional Visitor Center. All bids must be submitted with an original and three (3) copies to the Jefferson County Purchasing Agent, 1149 Pearl Street, 1st Floor, Beaumont, Texas 77701, no later than 11:00 AM, February 1, 2011. Bids will be opened at that time.

Specifications and plans are available for purchase—at cost—from a print shop in Beaumont. Documents will be available as printed sets or as digital files on CDs. Contact The Labiche Architectural Group, Inc., 7999 Gladys Avenue, Suite 101, Beaumont, Texas, telephone 409-860-0197 for print shop and plan room information.

The County shall require the bidder to furnish a bid security in the amount of five percent (5%) of the total contract cost. The bid bond must be executed with a surety company authorized to do business in the State of Texas. Within ten (10) days after the date of the signing of a contract, the bidder shall furnish a performance bond to the County for the full amount of the contract, if the contract exceeds one hundred thousand dollars (\$100,000). If the contract is for one hundred thousand dollars (\$100,000) or less, the County may provide that no money be paid to the contractor until completion and acceptance of the work or the fulfillment of the purchase obligation to the County.

A Mandatory Pre-Bid Conference will be held on Wednesday January 5, 2011 at 10:00 AM CST. The conference will be held in the Ben Rogers Visitors Center Conference Room, 5055 IH 10 South, Beaumont, TX 77705.
