Clarifications

Question: Are you able to provide an estimated budget/value range for this project?

Answer: As the County/Airport is requesting Statements of Qualification for this project, an estimated budget/value range is unavailable to potential respondents. Consultant(s) will be selected based on qualifications and experience, with fees determined through negotiations following the evaluation of all responses received.

Question: Is there a Bidding Construction Timeline for this project?

Answer: The timeline for the awarded Engineering Firm for this RFQ will be to have bids in-hand for the construction phase by April 2022.

Question: Does the County want verification that the Primary Consultant is registered with System for Award Management (SAM), as well as any Subcontractors for the project?

Answer: The County requires only the Primary Consultant be registered (active and in good standing) with the System for Award Management (SAM).

Question: Regarding item #2 on Page 5: *Provide resident project representative (RPR) services*. Is the Prime firm required to have a person on site 24/7?

Answer: No, we require construction progress reports, verification of quantities, and construction oversight on federally funded construction projects. 24/7 presence is not required, periodical/routine inspection of progress is typical.

Question: Regarding Item #5 on Page 5: *Prepare changes orders and submit to Purchasing to formally execute in Commissioner's Court.* Is the Selected Prime consultant expected to prepare change orders for the project?

Answer: Yes. Typically, the Engineer performing construction oversight prepares change orders. Format of the change order is up to engineer.

Question: Regarding Form 1295, Item #6: Is the submitting firm (Prime) considered to be the interested party, and whose information is required in the section (name, DOB, etc.)?

Answer: The FORM 1295 submitted should be completed and signed by an authorized signatory representative with the Primary Consultant.
