1. Question: My firm provides Geotechnical, Materials Testing and Environmental Services. Can we submit on those services only?

Answer: Yes

2. Question: Can you please clarify the areas of expertise. The list of services on page 2 under "purpose" and page 3 under "area of expertise" are different. Ex. Geotechnical Engineering is no on page 2 and Environmental Services is not on page 3.

Answer: The list of services on page 1 of 5 of the specifications under purpose is what types of projects Jefferson County would use your services. The areas of expertise listed on page 2 of 5 of the specifications are your company's areas of expertise.

3. Question: Would Jefferson County like to see an organization chart included in the SOQ?

Answer: No.

4. Question: Would Jefferson County like information about Subcontractors in the SOQ?

Answer: Yes, see "Example of Area of Expertise Consideration Table" on page 2 of 5 of the specifications.

5. Question: When is the deadline for question submittals?

Answer: September 1, 2023 at 5:00 pm CT.

6. Question: Can the submitting fir organize the RFQ requirements 1-8 in whatever order as long as we include all of those requirements in the SOQ?

Answer: Yes.

7. Question: Can we include lengthier project descriptions in a project sheet format outside the Area of Expertise Consideration Table?

Answer: The Area of Expertise Consideration Table is required. If the evaluation committee wants a lengthier project description, our department will request this information for proposers during the evaluation process.

8. Question: Can the County please expand on what they want to see specifically for the **Ability to Meet Goals and Objectives for the Project**?
