Senate Bill 1612 has repealed the \$1.00 document Filing Fee authorized by Local Government Code 291.008(d).

Effective Jan. 1, 2025, filing fees for instruments to be recorded in the Official Public Records are \$25 for the first page (instead of \$26), and \$4 for each additional page.

The \$1.00 fee has been removed from all OPR filings, Assumed Names Certificates/Withdrawals and Marriage Licenses.
